PRESIDENT'S REPORT

Welcome to our latest newsletter. The cooler weather of recent weeks means winter is just around the corner and it is only one month until the official start to the 2017 ski season.

Bookings for the Lodge for this season have been steady. There is still room if you are considering a trip to the lodge this winter, however we encourage you to make your booking soon. There is plenty of availability for the period 16 July to 6 August and limited availability at other times.

The Lodge is in good condition for the season following an extensive working bee in March. Some further work is being done later this month to address some of the damp issues we have experienced in recent years including replacement of some beds.

Note that the National Parks is introducing a new electronic fee collection at KNP to improve the visitor experience although there will be no change to how fees are collected for the 2017 ski season.

The Board has recently approved amendments to the Club's By Laws to more accurately reflect our activities and revised processes.

BOOKINGS AT THE LODGE

The online booking system is easy to use. You only need to choose a period where accommodation is available, and make a booking. Note that Food store payment must be made at time of the booking. Members get bonus credit points for taking non-members to the Lodge. Remember that bookings are Sunday to Sunday.

TIPS FOR MAKING LARGE GROUP BOOKINGS

The online booking system has a feature that allows you to link together multiple booking applications under the same booking ID. If you are the group leader, first make your booking, then supply the booking ID number that is returned to you to the rest of your group. Other party members then fill in their own form linking to your booking. If your other party members want to use a separate Food store docket, they need to have a separate (but linked) booking.

FOODSTORE

Thank you to all those who responded to the survey on the food store post the 2016 winter season. We were not able to act on all the suggestions but we have enhanced the range of food available e.g. with some extra varieties of pasta (including gluten free), brown, basmati and arborio rice, curry paste, tinned coconut milk, whole grain mustard, chick peas, kidney beans, tinned beetroot, pasta sauces and tomato paste, olive oil, jars of olives, smoked oysters, rice crackers, Jatz biscuits, sweet biscuits, tinned cream. UPGRADED BY LAWS 2017

The Board at its March meeting has reviewed and approved the Bylaws with amendments and inclusions based on the existing

documents and a fresh look at the future direction of the club. The new Bylaws have been placed on the Website for all club members to read and understand. It should be remembered that the club has always used the Memorandum of Articles of the Association and the By Laws to rule the way the club operates.

The Memorandum can only be changed by all the members through the AGM or a special meeting. The Bylaw's provide more clarity about the internal operation of the club and are changes by the full Board of Directors meeting who then approve the changes.

The some changes to the Bylaw's will provide a new direction for the club and are detailed below:

- Allocation of Credits has been restricted for the short period to those working for the club or bringing a number of non-members to stay at our lodgings. The allocation of credits for membership units was stopped some years ago and was never intended to continue in the same form with the acquisition of the new lease. The By Laws still leave a provision to provide membership credits in the future.
- 2. The lodge captains at Pygmy Possum will from now on be awarded credits if they are responsible for more than two family groups. This is in recognition of the work they have done while on their own holiday at the lodge. The Board retains the right to allocate these points when they have determined that the lodge captain has provide a satisfactory service.
- 3. Guests who turn up to the lodge on the day requesting accommodation will only be granted accommodation if they are seen to be responsible adults and they will be required to pay an additional fee of \$20 or 10% of the cost of the stay, depending on which is greater, for our willingness to accept them in the lodge.
- 4. The Board has decided to remove associates and affiliates from our membership lists as the new lease will require an accurate list of potential people who will use the lodgings for the benefit of the park and it will make our accounting much simpler in our upgrade web database management.
