## **Annual Membership Subscription Fees**

Dear Member,

The annual Member Subscription fees for Elouera Ski Club are now due for the 2018/19 year.

The Annual fee has been set at \$55.00, inclusive of GST. Please find attached your invoice for the period 1 April 2018 to 31 March 2019.

The subscription fees have remained constant since 1 April 2015, however the Board has decided to apply a minimal increase to cover inflation and increased costs.

As reported recently, we have commenced discussions with Charlotte Pass Snow Resorts to enter into a new 40 year sub-lease for ongoing use of Pygmy Possum Lodge by our members, guests and the public. At this stage our ongoing operating and capital costs are not fully known. This uncertainty has also impacted on the Board's decision to limit the increase in the Member Subscription fee this year. Note that our fees are amongst the lowest at Charlotte Pass.

To ensure that the Club is able to maintain sufficient cash reserves to meet all our expenses, particularly those associated with the new sub-lease, the Board has decided that the annual Member Subscription fees be paid in cash. Accommodation credits will no longer be accepted as a form of payment or part payment of these fees. Cash payments will put the club in the best possible position to meet critical running costs and any unexpected costs associated with the new sub-lease.

Please note that accommodation credits can still be used when booking accommodation at Pygmy Possum Lodge and Castaways.

The club has sold all 600 membership equivalents and is not offering new memberships at present. Once the new sub-lease has been entered into the Board will review the Club's membership and make any necessary changes to manage and refresh our membership base. Memberships can be transferred or sold. At present there are approximately 10 members wanting to sell their memberships and we have had 6 membership sales in the last 6 months.

The Board requests that you use the BPAY® facility to pay your membership fee. This will ensure our accounting practices are easier to administer for the volunteer staff who are assisting the club.
